MEMORUNDUM ON BEHALF OF WORKERS AFFECTED BY
OCCUPATIONAL DISEASES DUE TO WORKING CONDITIONS
AND LACK OF SAFETY AT NUCLEAR ENERGY
CORPORATION OF SOUTH AFRICA (NECSA)

WE, EX - WORKERS AT NUCLEAR ENERGY CORPORATION
OF SOUTH AFRICA DEMAND THE FOLLOWING AS A RESULT
OF EXPOSURE TO CHEMICALS, RADIATION AND OTHER
INJURIES AT YOUR COMPANY:

1. SPEEDY COMPENSATION OF ALL AFFECTED WORKERS.
2. ACCESS TO YOUR MEDICAL FACILITIES FOR PROPER MEDICAL TESTS TO BE CONDUCTED IN A TRANSPARENT MANNER AND WITH THE INVOLVEMENT OF OUR REPRESENTATIVES / EARTHLIFE / AND OTHER INDEPENDENT MEDICAL PEOPLE TO MONITOR THE PROCESS.
3. COMPENSATION FOR ALL PEOPLE WHO DIED WITH OCCUPATIONAL RELATED DISEASES AS A RESULT OF WORKING AT YOUR COMPANY.
4. FULL CO-OPERATION IN RETRIEVING ALL MEDICAL INFORMATION INCLUDING FILES FROM HOSPITALS TO WHICH YOUR COMPANY REFERED WORKERS.
5. RELEASE ALL MEDICAL FILES WITHOUT TAMPERING WITH INFORMATION CONTAINED THEREIN.
6. REFRAIN FROM SENDING YOUR SPIES TO OUR MEETINGS WITH IMMEDIATE EFFECT.

7. REFUND ALL MEDICAL BENEFITS, HOUSE LOANS AND INSURANCES YOU DEDUCTED FROM OUR SALARIES.
8. RE-EVALUATE FOR COMPENSATION ALL OCCUPATIONALLY ILL EX-WORKERS WHO'S CURRENT PENSIONS ARE ABOUT TO DRY UP.
9. COMMIT PUBLICLY AND TRANSPARENTLY TO ONGOING MEDICAL EVALUATIONS, TREATMENT AND COMPENSATION OPEN TO ALL EX-WORKERS AT YOUR PLANTS, MANY OF WHOM WILL ONLY REALISE OCCUPATIONAL ILLNESSES MANY YEARS AFTER THEIR EMPLOYMENT, OFTEN UP TO 20 YEARS AFTER THEY WERE EXPOSED.
10. STOP DIFFERENTIATING BETWEEN EX-WORKERS EMPLOYED DIRECTLY FOR NECSA AND THOSE YOU EMPLOYED THROUGH SUB-CONTRACTORS-THEY WERE ALL SUBJECTED TO THE SAME INADEQUATE HEALTH & SAFETY MALPRACTICES.

WE AGAIN DEMAND YOUR RESPONSE TODAY, IF WE DON'T GET A RESPONDS TODAY WE ARE GOING TO MAKE A SLEEP IN OR SIT IN (SLEEP OVER). **ENOUGH IS ENOUGH.**
